

## **Rising Star Award**

### NOMINATION FORM

The Rising Star Award is given annually in recognition of a professional who has made a significant impact in their designated field during the first five years of the recipient's area of work as a director/manager. The rising star will have demonstrated a commitment to best practice and good governance, an ingenuity of thought that has the potential for having substantial and lasting influence upon industry standards, and demonstrates the potential to be a future leader.

### **ELIGIBILITY**

To be eligible for the Rising Star Award, a nominee:

- May or may not be a IDAPNG member
- Has served in their present area of expertise/specialisation no more than five (5) years
- Shows passion and has made significant contributions to their department, unit, institution, organisation, to the IDAPNG community, and/or in their designated field/industry
- Has engaged in activities such as:-
  - Organised or led an activity, or range of activities/services, within their organisation that promotes good governance
  - Demonstrated innovation in their area of specialisation
  - Presented at conferences and/or have engaged in publications of their work
  - Contributed to implementing best practice guidelines
- Shows promise in making further contributions in their designated field as a leader/expert

### **ASSESSMENT CRITERIA**

There are no restrictions of the type of activities or achievements for which nominees can be nominated, but nominators are expected to provide evidence demonstrating how the nominee is already making a contribution to improving corporate governance in the markets in which they operate.

Supporting documentation includes, but is not limited to, news articles, awards, letters, etc. that assist in highlighting the nominee's successful accomplishments.

Each applying or nominating individual or organisation may present their materials in the format that best highlights the nominee's achievements. Keep in mind this is an annual award, current achievements and contributions will be considered more significant than past accomplishments.

## **NOMINATION PROCESS**

Any interested person or organisation may submit nominations by submitting this form and related information. Candidates are vetted through a selection process based on competitive criteria. Our panel of judges may request additional information from the nominating party as required.

## **SELECTION PROCESS**

Nominations will be reviewed by the IDAPNG panel of judges which has been approved by the Board of Directors. The panel will independently review applications and select, by a two-phased voting process, the proposed award recipient.
